TERMS AND CONDITIONS FOR LEASING OF COMMERCIAL ESTABLISHMENTS THROUGH E-TENDERING SYSTEM

Technical Bid

(Under e-procurement portal)

- 1. Applicants shall have to participate through the process of e-procurement only and the applications submitted directly will not be accepted.
- 2. The Applicant can engage the Yatri Nivas building for the purpose of providing the Boarding and Lodging facility only for the tourists.
- 3. Applicants should have an experience in Management of Hotel Business for not less than three years with annual turn-over of atleast 06.00 Lakhs annually over last three years.
- 4. Jog Management Authority cannot be held responsible for technical problems resulting in non-submission / non-uploading of documents within the stipulated time.
- 5. The bidder shall bear all costs associated with the preparation and submission of his bid and Jog Management Authority will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- 6. The Contract Lease period is six years from issue of workorder.
- 7. The Successful bidder should pay the full bid amount before signing the contract agreement with Jog Management Authority, Shimoga.

- 2. If sucessfull bidder refuses to operate and maintain for Six years or leaves before Six years, then Security Desposit will be forfeited.
- 3. The bidder is advised to visit and examine present building condition of Yatri Nivas, Jogfalls and it is his own responsibility to obtain for himself all information that may be necessary for preparing the bid and entering into contract. The costs of visiting the site shall be at bidders own expenses.

- 4. The person signing shall state the authority under which he is signing / acting on behalf of Partnership Firm / Company and enclose the certified copy of the partnership deed / memorandum and articles of association issued by the authorities.
- 5. The bidder shall pay the processing fee and EMD through e-procurement following four modes of payment:

 - Credit Card
 - OTC (Over the counter)
 - NEFT (National Electronic Fund Transfer)
- 6. The Bidder is expected to examine carefully all instructions, conditions and terms in the bidding documents. Failure to comply with the requirement of bid submission will be at bidder's own risk. The bids which are not substantially responsive to the requirements of bidding documents will be rejected.
- 7. Persons quoting highest bid amount and produce valid documents will be selected as Successful Bidder. For unsuccessful bidders EMD will be refunded without any interest.
- 8. The successful bidder will be decided on the basis of highest lease offered as per the price sheet.
- The Bidders shall at no point of time engage the services of child labour at the place of business.
- 10. Bidder shall not sell any prohibited items identified by Jog Management Authority.
- 11. The successful bidder shall at the time of entering into an agreement produce the VAT registration certificate under the KVAT Act of 2003.
- 12. Jog Management Authority reserves the right to accept / reject / revise / post-pone the tender without assigning any reasons.
- 13. Payment of Service Tax: The Bidder shall pay <u>Service Tax</u> payable to the government as per rules. Any delay shall lead to interest and penalty as applicable.
- 14. The bidder has to upload copy of the address proof, contact details and a certificate that the three years turn-over in Hotel business was not less than Rs. 6.00 Lakhs in any one financial year duly certified by a Chartered Accountant.

- 15. The Jog Management Authority will have the right to terminate the agreement by serving one month notice in advance to the Bidder without assigning any reason.
- 16. The rates offered by the Bidder shall be exclusive of all Govt. Taxes / Levies, Corporation Taxes, property taxes, urban taxes, cesses or any other taxes that may be imposed by any authority in future.
- 17. In case death of the Bidder, by getting consent of his family members and obtain certification from concerned authority to transfer agreement, to one of his successes or with their own cost.
- 18. In case of Ill-health of the Bidder and if he is not able to manage the activities then by getting consent of his legal heirs and on producing of Medical Certificate (Not less than the rank of Dist. Surgeon) the agreement may be suitably changed to allow one of his legal heirs to replace the bidder and all such agreements shall be executed at the cost of the representative of the successful bidder.
- 19. Any type of Physical modification of the building structure, new Construction or extension of building, additional/up-gradation of facilities without any prior approval of Jog Management Authority will be treated as breach of the contract and Contract shall be cancelled and Terminated.
- 20. Only existing building is part of this contract and Jog Management Authority reserves its right to use the land surrounding Yatri Niwas for any Purpose.
- 21. Jog Management Authority can rent/lease/give on Contract land surrounding Yatri Niwas building to any other third Party/Organisation/Individual without informing or taking consent of successful bidder of "**Outsourcing of Operation and Maintenance of Renovated Yatri Nivas (fully furnished) Hotel Building at Jogfalls** ".
- 22. Jog Management Authority also reserves the right to claim from the successful Bidder (s) for any loss sustained for their misuse of building / not abiding by the Law of the Land / causing damages to building allotted to them.
- 23. If Restaurant/Canteen Opened in Yatri Niwas, Kitchen and eating area should be maintened properly and should be hygienic. The successful bidder should collect the waste generated as per Municipal Solid Waste (Handling and Management) Rules and to be transported to the nearest collection point of the local authority at his own cost.
- 24. The Successful bidders should not cut the trees/branches without the prior permission of the concerned authorities as per law.
- 25. All the Safety Precautions towards fire accidents and electrical accidents etc should be taken care by the successful bidder.
- 26. The expected Contract rate and for any other reason is not satisfied in Auction, the Deputy Commissioner or Concerned Authority have rights to cancel the Auction.

- 27. The bidders shall produce the original documents on or before opening at the Deputy Commissioner's Office, Shimoga. The failure of the bidders to comply with this provision shall lead to rejection of the bid.
- 28. If the bidder violates any of the above terms and conditions, The Deputy Commissioner, Shimoga District has right to terminate the agreement without prior notice and may claim the loss incurred if any from the successful Bidder.
- 29. The Tax Deducted at Source shall be effected by the Jog Management Authority as per the provisions of the Income Tax Act.
- 30. In the event of any difference in the interpretation of any of the clauses of the Contract Agreement and / or the documents, the clarification given by Deputy Commissioner and Chief Executive Officer, Jog Management Authority, Shimoga shall be final and binding on the Parties.
- 31. Any dispute or difference whatsoever arising between the parties out of or relating to the effect of the Lease agreement or the validity or the breach thereof, shall be referred for settlement to the **Deputy Commissioner**, **Shimoga** and the award made in pursuance thereof shall be binding on the parties concerning to the arbitration.
- 32. Any dispute whatsoever shall be subject to the **Jurisdiction of Shimoga Courts only.**
- 33. Parking for Yatri Nivas to be maintained by sucussfull bidder and the bidder cannot expand restaurant/dining facility out side existing building without prior opproval/permission of authority.
- 34. If any breach of above condition agreement or contact would be cancelled by authority without any notice or any reason.
